"The protection for church members that is provided by open meetings, dissenting voices and congregational votes is a cherished Methodist tradition, and it

There was not enough space in the last text box, so I am answering this question here. Is there anything else you want the church council to know or consider in the discernment process? The congregation is unaware of many important facts about the status of the UMC. The weekend of November 5th, 2022, the UMC voted on new members to the Council of Bishops and no traditional bishops were elected. Traditionalist views are no longer represented or wanted in the UMC "big tent". Todd stated at the July church council meeting and to Sunday school classes that the UMC Articles of Religion can not be changed. However, that does not stop pastors and bishops from breaking their vows to the UMC and to God by doing what they want with no repercussions from the governing bodies of the UMC. Bishop C. Joseph Sprague stated a speech on January 28, 2002, "I cannot believe that His resurrection involved the resuscitation of his physical body". New Bishop Kennetha Bigham-Tsai is quoted from her September 2022 delegation interview. "No, it is not important that we agree on who Christ is." There are many more examples of how pastors, bishops and seminary professors are abandoning the Articles of Religion. Even if the Articles remain, what difference does it make if the leaders and seminary educators are teaching conflicting doctrine? I disagree that someone who has never darkened the doors of our church can claim to be a professing member and vote. This is disrespectful to the members who have given years/decades of their prayers, presences, gifts and services to the church. If you are using the results of this survey to inform church council, you have used a working copy of the current church roll. It is only fair that that same roll be used for voting. If it needs to be updated there is time to do that before the voting takes place. It would be a disgrace if this survey is used as a reason to not allow members to vote. I hope that staff members will plan to be transparent and share survey results with the congregation.
