Not that it's helpful but I just think this whole situation is ridiculous. This shouldn't be what the church is about

On a personal level, I would prefer to stay as part of the United Methodist Church.

Pitting people against each other who now have long-time relationship is a terrible idea and could destroy FUMC. If a huge number of people leave due to a divisive vote, how will we pay to maintain the physical plant. Who will be left to attend services? People will be discouraged, negative, and down on the future of the church. It could even drive them from God.

FUMC-LBK is a very educated and relatively sophisticated congregation. Our workplaces (universities, medical systems, government employment, etc.) have been legislatively made to have broad inclusive workforces. Gender orientation is a non-issue to us and our children raised since the 1980's when these laws were put in place. I also view the Bible as a path to Christian discipleship, but not literally word for word. This movement appears insane to me.l

I commend the church council for their diligence and impartiality. We need to pray fully consider what we are trying to accomplish and that change to the discipline is a serious matter.

I joined FUMC because I felt it welcomed all belivers in Christ. I would like it to continue.

I feel that the Church Council is not necessarily the best broad spectrum of representation of the whole church but does cover some of the important areas. An example that shows a lacking area is a representative who speaks, as a whole, from the Sunday School classes, in toto. As someone who has previously served on the council, I've always noted some lack of representation. And to show my age, I feel that the use of an Administrative Board was more representative.

I feel that rushing the process would be unwise. There are still issues which must be worked out by the conference before we can decide on our course of action.

Set a date for the vote as soon as possible

Please don't hurry. Please don't vote.

The church council has less information than I do on the matter. I contacted 5 members of the council to obtain their opinions and realized they were either misinformed or did not have much information. FUMC needs to spend the next several months providing as much information to the members as they can and then let us vote.

If the church council does hold a vote I hope they make every effort to give everyone present enough information to make a very informed vote without swaying the vote either way. I feel there has been plenty of info/data but afraid quite a lot have not taken the opportunity to understand the issue. I would hope they would not show up to vote not knowing all the issues and ramification of their vote. "Notvoting" does not take our church/congregation down uncharted territory, or split the church.

My mom goes to Polk Street in Amarello, and they have followed a very different path. I feel fortunate to have had information from both FUMC and Polk Street. I have also done my own research.

I feel like instead of focusing on particular sins, we should do a Jesus did an reach for the humans. Embrace them and allow them to grow. I wish we could view others as: what if that was my son? daughter? aunt? uncle? child? What would I want for them and how others should treat them. There are plenty of things we tend to be divisive about and that is not what Jesus came to do.

I'm praying for you all as this process moves forward.

I think many churches have acted hastily... Even if the council decides to hold a vote, I would hope it would be as late as possible... As we will have time to see some of the possible downfalls of disassociation by some of the other churches that opted out early in the process.

For me, it's important that members know what's at stake if we stay United Methodist after January 1, 2024, and predictions come to pass that FUMC members do not feel we can support. Then, the choice to leave could be a devastating cost.

Choosing to vote or not vote will likely result in strong opinions on both sides. While it may seem like a lose-lose situation, my hope is that Christ's love for all of us prevails and that we demonstrate kindness towards one another in the midst of our human struggles.

Let's continue to take our time, NOT rushing to a vote, if at all. This dilemma is a serious one that will affect future generation, as well as our own legacy, but it has helped us as a community of faith to learn and discern without hating the other side.

Don't listen to the extremist.

I thought you were just wasting time. Now you're wasting money, too.

FUMC has provided excellent leadership throughout the community for many, many years and has always been open to varied viewpoints. I hope the church council will uphold this tradition and the rich history of FUMC.

I hope the church council will keep in mind the long, rich history of FUMC which has always been accepting of varied views and has provided leadership within the community.

The FUMC church council must consider that the connection system makes possible the best outcome for all areas of ministry.

I don't think the UMC will hold the same line in the future that we have held in the past. I have always thought that the UMC has been a rare combination of tradition and growth/change. I feel that the UMC will skew far away from tradition and conform more and more to worldly values. My preference would have been for there not to be a split in the first place which would allow for two forces to continue to balance each other out, but it is too late for that.

Can we just be the First Methodist Church?

The Church is supposed to be salt and light to the world. We are not supposed to conform to the world like UMC is doing.

This subject has to potential to be very polarizing, and probably already has. But we don't need to let it get to the boiling point like current day politics (left vs right, liberal vs conservatives) where there is no working together, and no compromising. I truly believe our church body is made up of 80-90% reasonable level headed, accepting members, with 5-10% either either extreme (ultra progressive/conservative).

No.I think our members need to know the possible ramifications of choosing to stay with the UMC. In particular, if we stay it is almost a certainty the Book of Discipline is going to change. I am in favor of disaffiliating from UMC and joining GMC at this time. I also do not like that we are having to make this decision with our church, but I feel that we should protect the current discipline as it is written and should be enforced.

Continue to pray for the correct decision

Jesus taught us to love our neighbors as ourselves and warned us not to judge. The issues that prompt a vote to disassociate are not in accordance with His teaching.

I think it's been handled very gently, sensibly, and fairly.

I only hope the council will try to lead the church in a godly path, treating everyone with the love that Jesus taught us and not try to shove any single attitude in our faces to overwhelm another train of thought.

Our church history is based on inclusiveness with LGBQT people serving in ministry. This should not change

I would like for the videos that are avaiable to be distrubuted to Sunday School classes and made available to all interested members so that they understand what the options are and why not voting is a viable option.

What would Jesus do?

I would just like us to hold steady on our traditions and values that are based on the bible. Everyone is certainly welcome to our church, but the outside political pressure to change who we are and what we do should not have an influence on how we operate.

I want us to stay FUMC - NOT global!!! If that means we have to be "independent" in order to make everyone happy, then so be it!

Exclusion is not the mission of Christianity

First Methodist Church of Lubbock should remain affiliated with the United Methodist Church for one reason: Jesus turned no one away. He spoke to lage masses of people including sinners and saints. He dined with sinners. In Mark 2:17 Jesus states, "...I have not come to call the righteous, but sinners." How can we live our mission, "...to create a grace-filled environment in which Christ transforms lives" if we start excluding people who need Christ the most?

I want our church to be true to the Scriptures inspired by God rather than blending with the culture of the world.

Splitting us, or even having the vote, would lead us to discontentment with our members. We need people to attend.

I think a vote only allows the loudest voices more volume. We do not need to make corporate body decisions based on membership votes. The institution is inherently not democratic, but "compassionately" authoritarian, otherwise it fails because of votes. Sowing discord sets up a barrier between us and God. We need to spend more time with God, not voting. Let people leave or stay individually, they can vote with their feet -Will Boyles

We need clear, understandable, unbiased information that is disseminated to the ENTIRE membership, not just those that attend Sunday School, small groups, or the rare meeting of the church council. MANY members have no idea what is happening or what each option will mean to our church. It's not possible to do proper discernment without proper COMPLETE information and I feel that this information is being withheld from the congregation.

I am concerned about the fact that so many in our Conference are choosing to disaffiliate. I understand that our area is uniquely conservative and apparently there are issues from the past but I don't fully understand why our numbers are so out of line with the rest of the country. The council and First leadership have pointed us to multiple reliable resources to help in the discernment process but with so many voices out there it can be easy to be misled.

Consider membership rolls out validity
